

#### **Investment Criteria**

Deepbridge prepares and reviews the investment opportunities it sources from its wide dealflow network. Generally, Deepbridge seeks investment opportunities that exhibit the following qualities:

- Technology-driven businesses with a clear and realistic path to commercialisation.
- Significant market potential with clear need and market growth.
- Businesses that utilise a technology-derived platform and/or an innovative approach to meet a newly-identified or existing market demand.
- Innovation-driven products that have the potential to create new market segments or displace current market offerings.
- Robust intellectual property which may or may not be patented.
- Experienced, passionate and energetic founding team.
- Clear exit strategy to be implemented within the medium term.

Ultimately, Deepbridge will select companies which offer the opportunity to expand internationally, utilising many of the strengths, contacts and experience that the Deepbridge team possess in order to accelerate the growth of the business.

# **Investment Strategy**

The Deepbridge Technology Growth EIS will only be invested in Investee Companies which propose to follow a conservative business model that is in line with the investment strategy of the Deepbridge EIS. In doing so, Deepbridge intends to appoint one or more of officers from Deepbridge to the board of each of the Investee Companies, once the decision to invest in each such company has been made. Any decisions or actions required in relation to the investor's rights and interests in the Investee Companies will be taken by the Manager, acting in its sole discretion. Deepbridge will provide monitoring services to each Investee Company, including appointing a director to the board to assist the Investee Company in delivering and monitoring adherence to, and compliance with, its business plan.

Deepbridge are one of only a handful of providers who usually deploy EIS funds on a monthly basis. ### Thorough due-diligence process

Deepbridge receives in excess of 1000 of applications from companies seeking investment every year. Prior to investment, each prospective company is also subject to a review from the Deepbridge Supervisory Investment Committee, which is made up of several internal and external expert individuals, who collectively determine the appropriateness of each investment.



#### Sector experienced investment team

Deepbridge only invest in sectors in which the team has in-depth experience; technology, life sciences and renewable energy; allowing us to appreciate where, how and why our investee companies operate. This gives us a better understanding of how to support, mentor and manage those businesses.



#### Hands-on and active approach

Deepbridge takes an active role (not just a Board seat) to guide, mentor and counsel each of our investee companies. The provision of hands-on operational experience combined with financial expertise aims to mitigate the investment risk borne by the Investor.



### No investor fees at point of investment

Investors pay no management fees at the point of investment, for subscriptions into the Deepbridge Technology Growth EIS received by a financial adviser. Fees are charged to the investee companies, ensuring up to 100% tax efficiency for investors. This also allows 100% allocation of investors subscription, meaning they are receiving more company shares versus if we charged them the fees prior to deployment.
