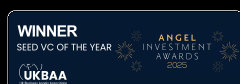

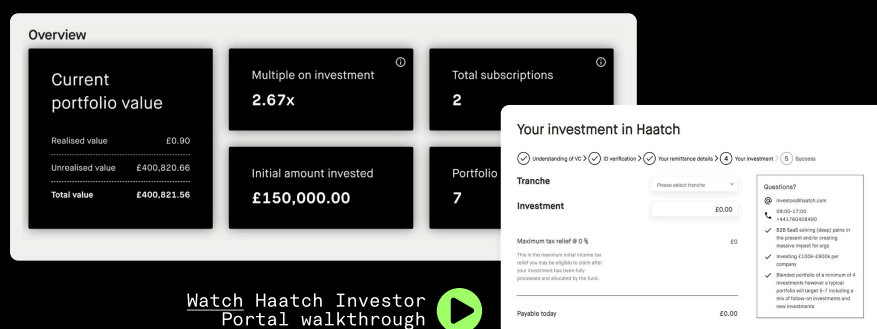

## Haatch EIS Fund at a Glance

- **Portfolio Focus** – 4-6 seed stage B2B SaaS businesses solving deep pains and/or creating significant impact for organisations
- **Minimum investment** – £20,000
- **Target return** – 3x invested capital
- **Investment holding period** – 5-7 years
- **Deployment** – Fully invested in the 2025/26 tax year

## Tax Benefits of EIS

- **30% Income Tax Relief** up to 30% income tax relief on the amount invested, claimable against income tax in the current or previous tax year.
- **Tax-free growth** no Capital Gains Tax (CGT) payable on any gain if the shares are held for at least three years and EIS conditions are met.
- **CGT Deferral Relief** CGT arising from the disposal of any asset can be deferred by reinvesting the gain into EIS-qualifying shares, for gains arising up to three years before or one year after the investment.
- **Loss Relief.** If the shares are disposed of at a loss, you can elect that the loss be set against any income tax of that year or carry back to the previous tax year.
- **Up to 100% IHT relief** is available if the investment is held for two or more years at the time of death.
