Application

You can download the form for or request digital application process via jb@symvancapital.com

Once the application has been completed and signed, submit to jb@symvancapital.com



Verification

Symvan submit the application to the custodian, whereupon if any additional information or identification is required, they will contact the adviser.



Payment

Once approval from the custodian comes through, Symvan issue payment instructions to the adviser.

Once payment has been received and matched, Symvan issue a letter to the adviser with the information on deployment, certificate and details for the portal.



Portal

Once a deployment is made, both the adviser and investor receive links to register for the portal.

The portal is updated as and when deployments are made, EIS certificates are issued and quarterly reports published.
